THE TRUST ESTABLISHED A POLICY THAT REQUIRES THAT FUNDS BE SET ASIDE AS PART OF THE ACQUISITION OF EACH CONSERVATION EASEMENT. IT IS THE POLICY OF

THE TRUST THAT THESE FUNDS BE INVESTED AS A PART OF ITS PROJECT FUNDING POLICY. THESE FUNDS WILL BE INVESTED TO PREVENT LOSS OF PRINCIPAL WHEN POSSIBLE. AS A PART OF THE ANNUAL BUDGET PROCESS, A PORTION OF THE EARNINGS WILL BE INCLUDED IN REVENUES EVERY YEAR TO COVER THE COSTS OF BASELINE DOCUMENTATION, ANNUAL MONITORING, AND TECHNICAL ASSISTANCE TO THE LANDOWNERS.
